2020 GENERATION STATISTICS

Generation & Supply to National Grid


The Bui Generating Station (BGS) was projected to supply 764 GWh of electricity to the National Interconnected Transmission System (NITS) in 2020. This projection was however revised at the end of the first half of the year to 1,213 GWh based on the observed dispatch trend by the System Operator (GridCo) and hydrology predictions obtained within the period.

The total energy generated at the BGS in the year 2020 was 1,269.52 GWh, 1,241.89 GWh from the Main Plant and 27.63 GWh from the Turbinitte. The generation from the BGS represents about 6% of the total electricity generated (19,658.31 GWh) in Ghana in 2020.

A total of 1,266.50 GWh, representing 104% of the 2020 revised supply projection, was supplied to the NITS from the BGS. This represents and increase of 22% over the 1,034 GWh supplied to the NITS in 2019. The peak monthly electricity supply was 124 GWh, recorded in march 2020.

The table below provides details of electricity generation by the units and monthly electricity generation and supply for 2020 respectively.

The net export from the Tsatsadu generating Station (TGS) from commissioning in September 2019 to December 31, 2020 was 207,313.31 kWh.

BPA Policy

1.0 INTRODUCTION


Bui Power Authority has in the past instituted measures against infectious diseases, including the novel coronavirus (SAR-CoV-2). With the evolution of and further knowledge about the novel coronavirus, there has been the need to adopt supplementary protocols. These supplementary protocols bring clarity to further actions to be taken in the event of a confirmed positive case at BPA.

2.0 STRATEGIES

In response to the COVID-19 pandemic in Ghana, BPA has put in place two (2) main strategies as part of efforts to control the spread of the virus within all its operational areas. These 2 strategies are:

1. Leading Indicator Tracing: Proactive Strategy

The Authority through the GSD-HSE Unit continue to lead in the implementation of the Preparedness and Response Plan to the CORONAVIRUS (COVID-19)
Pandemic. Internal controls mechanisms are being continually strengthened in line with the HSE Management systems against the COVID-19 pandemic and other infectious diseases.



2. BPA COVID-19 Policy Initiatives

To reduce risks of infection, BPA has put in place some Policy initiatives as follow:

- i. Procurement of Personal Protective Equipment and strict use of such PPEs
- ii. Staff working from home in batches
- iii. Staff taking early annual leave
- iv. Suspension of Excursions and trips to BGS
- v. Access restriction and movement limitations to the Authority's facilities
- vi. Daily screening of all workers at the BGS, Tsatsadu Generating Station (TGS) and BPA Heights
- vii. Daily screening of contractor staff/laborers on all construction sites
- viii. Accessing BPA Cafeterias in batches to ensure social distancing
- ix. Periodic updates on the pandemic on BPA Social Media platforms, etc.
- x. Daily updates to Executive Office and staff
- xi. Weekly brief to the Executive Office
- xii. Inauguration of an Infectious Disease Control Committee
- xiii. Procurement and supply of Immune-boosting Supplements


These policies are being strictly followed to curb the incidence of COVID - 19 pandemic within BPA operational areas, thus preventing any interruptions in our operations.

2.1 Mandatory Protocols

Following these policy initiatives, some mandatory protocols are being implemented to reduce the risks of exposure of staff to the COVID-19 virus.

These measures include:

- Regular washing of hands with soap under running water
- Sanitizing of hands regularly and before handling commonly used items
- Screening of all Staff and visitors before entering the workplace (checking of temperatures)
- Wearing of face masks and practicing Social/Physical distancing
- Testing for the SARS-CoV-2



HYDRO-SOLAR-HYBRID

Commissioning

The President of Ghana, Nana Addo Dankwa Akufo-Addo, commissioned Ghana's first Hydro-Solar Hybrid power generating system, which includes a 5MW Floating Solar PV System, also the first in the West African subregion at the BGS. This forms part of the first phase of a 250MWp BPA's solar project, which is being implemented in phases of 50MWp by the Authority.

In a speech read on his behalf by the Senior Minister, he stated that the facility reiterates Ghana's resolve to diversify the country's energy generation mix to include renewable energy (solar, wind etc). The project, when completed, will add 250 megawatts of power to augment the Bui Generating Station's 404MW hydroelectric dam.

The Board Chair, Amb. Afare Apeadu Donkor, said the construction works on the phase two of the project in addition to the novel Floating Solar Plant, was progressing steadily. The Board in addition, he noted, had spearheaded the construction of essential foundational services to stimulate economic growth and quality of life that would open up the economy and stimulate growth at the Bui dam



The Bui Power Authority (BPA) has received a novelty centre dubbed the FRED OWARE INNOVATION CENTER (FOIC) from the sole financier of the centre, Fred Oware.

Mr. Oware who is the Chief Executive Officer of BPA solely funded the innovation centre from his personal funds for the project affected people and neighboring communities youth of the BPA Resettlement Township.

Ambassador Afare Apeadu Donkor, the Chairman of the Board of Directors of the BPA, together with the Chief of Bui, Nana Kwadwo Wuo II and the District Chief Executive of the Banda District Assembly, Ms Mary Konneh commissioned the centre.

In receiving the centre to be managed on behalf of the community, Ambassador Afare Apeadu Donkor said "it is our very firm resolve that this legacy will continue and outlive Fred's tenure because of the immense benefits it has for the people of this community. The centre will be managed by the BPA under our Corporate Social Responsibility pledges to continue in your good works to promote your vision and mission by developing a scheme to ensure the continuous sustenance of this centre in the years to come."

The FOIC will expose students to the world of science, technology, and robotics. According to Mr Oware, the centre should help curb the fear of mathematics and science. He also believes that "maybe the next Albert Einstein will come from Ghana and not from any rich home but a community such as Bui."

Nana Wuo II enstooled Mr Oware as the Development Chief with the stool name "Nana Ababio Oware".









ENERGY AWARDS By Gabriel Apatu

The Chief Executive Officer of the Bui Power Authority, Fred Oware, was adjudged the 2020 Energy Personality of the Year at the 4th Ghana Energy Awards, the most prestigious title at the awards. The Bui Power Authority also won the Clean Energy Initiative of the Year and the Energy Company of the Year (Renewable). This is the second year running that the Authority has won the Energy Company of the Year (Renewable). The event was chaired by the Akwamumanhene of the Akwamu Traditional Area, Odeneho Kwafo Akoto III, GEA 2020 and attended by the energy industry players and several representatives of government, various heads of organisations and the diplomatic corps; including the Economic Counsellor at the US Embassy, Hagen Maroney, Ambassador of the Republic of Korea to Ghana, Mr Kim Sungsoo as well as Dorothee Dinkelaker from the German Embassy, Arndt Wierheim, Director KFW and Vanessa Eidt, Portfolio manager of KFW.










CHRISTMAS PARTY; WORK HARD, PLAY HARD By Nana Kwesi Taylor


It was a night full of merry and mirth to remember and unarguably, the best way to usher in the festive season.

Open the eyes of my heart.


Lean me towards touching the bases.

fulfillment from knocking down challenges


7. You are the Outstanding Worker for GSD for 2020, how do you feel about that and what does it mean to you?

3. What are some of your major challenges you encountered during the project(s)?



When they are not at work, you will most likely find the diminutive figure of Abraham dazzling on the football field, while Noah is busily attending to his farm.






TALES OF NATIONAL SERVICE


