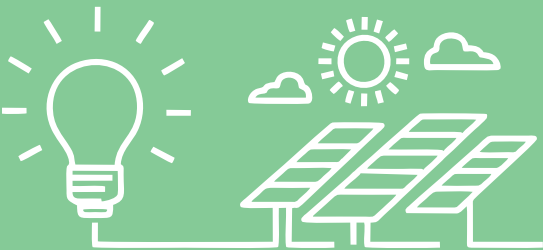

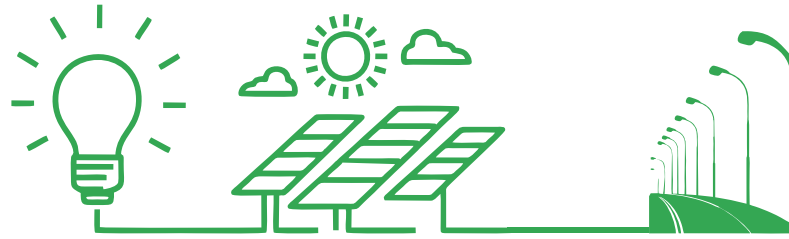

The first five players selected from the BPA's Talent Development Program have commenced their training with the John Paintsil Football Academy in Accra. The "Fantastic Five," were selected under the Memorandum of Understanding (MOU) between Bui Power Authority and the John Paintsil Football Academy to harness football talents in the Bui enclave.

The MOU stipulates that between 2022 and 2023, the Authority will organize scouting matches for the communities around the BGS.

The "Fantastic Five" will also be given professional training at the Academy for 12 months; with the hope that they will make it further into local or international leagues.

To improve a variety of sporting skills as well as talents within the Bui enclave, the Authority has initiated the process of constructing a two 500-seater Astro Turf Stadium with VIP Lounges. This proposed ultra-modern sporting facility has the potential to help unearth sporting talents who will qualify for sponsorship under the BPA's Talent Development Program.



The Authority in 2019 instituted the BPA Education Scholarship Scheme to support “Project Affected Persons” who have gained admission to Public Tertiary institutions in Ghana to pursue science related programs.

For the 2023/2024 academic year, the scholarship scheme was expanded to include communities from the four major traditional areas within the Bui Acquired Lands - Banda, Bole, Jama and Bamboi Traditional Areas. A total of ninety (90) applications were received from the four traditional areas. The BPA Scholarship Committee screened the applications and selected sixteen (16) beneficiaries who are currently enrolled in various tertiary institutions.

The Bongase Landing Site project has commenced and is expected to be completed in twelve months. The project which is being funded by Bui Power Authority is aimed at boosting fishing activities within the communities situated in the Bui enclave

In addition, the Authority is currently working on the development of the additional 4MWp Floating Solar Plant on the Bui Reservoir, a land-based Solar PV farm, and an initial 10MWAh battery energy storage system to enhance our operations.

Furthermore, we have taken proactive measures to enhance fire emergency preparedness and response at the BGS, by signing a Fire Protection Service Agreement with the Ministry of Interior on behalf of the Ghana National Fire Service (GNFS). This will ensure the establishment of a Fire Station at the Bui Generating Station (BGS) to protect lives and property within the Bui enclave.

As the Chief Executive Officer, I firmly believe that timeliness and effective communication are the key attributes to the success of any organization. The adage, ‘The key is in not spending time, but in investing it.’ by Stephen R. Covey rings true. Efficient time management leads to the timely completion of tasks, increased productivity, and improved work quality. Hence, I urge all staff members to be time conscious.

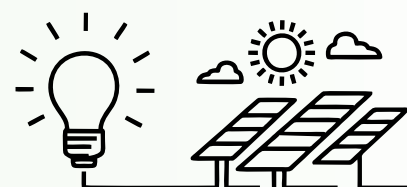

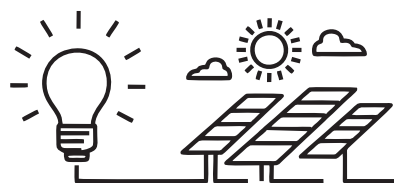


BPA BOARD VISIT

In his remarks, the CEO emphasized the importance of the project to the community and the need for the contractors to work within the time frame specified as well as maintaining a high standard of health and safety.

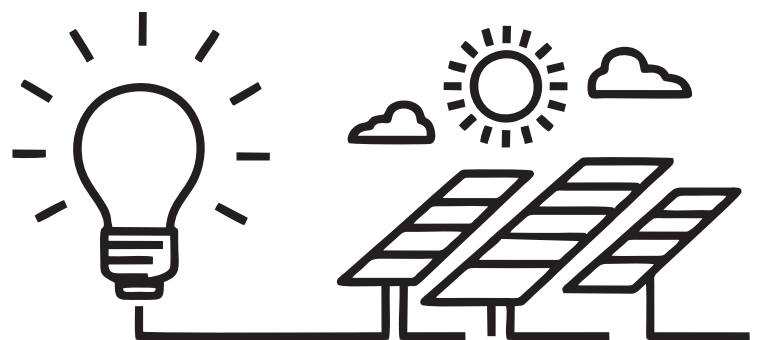
He stated that, "For us in Bui Power Authority, excellent organisational Health, safety and environment is a major standard we follow religiously".

CEO INSPECTS THE DAM GALLERIES

Hon. Samuel Kofi Ahiave Dzamesi, CEO on Thursday, 9th March 2023, inspected the Dam Galleries of the Power Operations Department (POD). This inspection was undertaken as part of his working visit to the Bui Generating Station.

Leading the CEO on the tour of the Galleries and its operations were Ing. Kwaku Sarpong Akosa, Director, Engineering Services and Ing. Philip Ato Ankoh, Deputy Director, Dam Studies and Engineering Development. They were accompanied by Ing. Samuel Nimako, Director POD as well as Deputy Director OHSE Chrisentus Kuunifaa and some staff members of BPA.



BONO REGIONAL MINISTER VISITS THE BGS

The CEO of Bui Power Authority, Hon. Samuel Kofi Dzamesi on Wednesday 29th March, welcomed the Bono Regional Minister, Hon. Justina Owusu-Banahene to the Bui Generating Station.

The Bono Regional Minister was on a two-day working visit to the Bui Generating Station to familiarise herself with operations of the Authority.

The Minister was accompanied by nine (9) Municipal and District Chief Executives (MDCEs) within the region and members of Bono Regional Security Council.

As part of activities for day one, the Minister visited the 3 infantry battalion at Dokokyina where the BPA CEO, Hon. Samuel Dzamesi presented a 50" Color TV to the military detachment to enable them keep abreast with news. He also assured the military of BPA's support in terms of deploying solar panels to generate electricity for their basic use.

The entourage then inspected the on-going Sugarcane Plantation project by the Bui Sugar Factory Limited under the auspices of BPA's Bui City Development Concept.



The over 6,940-hectare plantation situated at Fawoman community in the Banda District, upon completion, will become the largest sugarcane plantation in the country. The processing plant is expected to process about 60,000 tonnes of sugar annually, and will be developed in four phases which will eventually result in a total production capacity of 100,000 metric tonnes annually.





BPA MAKES BACK-TO-SCHOOL DONATION TO RESETTLEMENT TOWNSHIP SCHOOLS

The Community Relations Unit on 17th January, 2023, donated some snacks on behalf of the Authority to the Bui and Jama Newtown Primary schools to usher in the new academic year and consequently welcome the new entrants into the schools. The 'Back-To-School' Donation saw the kids receive boxes of assorted fruit juices and biscuits, along with learning materials.



The items were received by the headmasters of the schools, Mr. Steven Baako of Jama Primary and Mr. Billey Sampson of Bui Primary, in the company of some teachers. With the donation, the Authority hopes to motivate the students to achieve excellence during their stay in school.



BUI POWER AUTHORITY RENOVATES CLASSROOM BLOCK IN BONGASE

On a working visit to the BGS and the Bui Enclave, The CEO, Hon. Samuel Kofi Dzamesi handed over a renovated 6-unit classroom block to the District Chief Executive of the Banda District at a ceremony held at the Bongase Primary School.

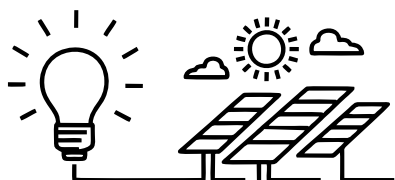
The renovation of the classroom block was undertaken in response to a request made by the assemblyman Hon. Peter Dongi and opinion leaders of Bongase through the DCE's office. The project was awarded to a local contractor, Mr. Solomon Mensah of Duapa Construction Limited at a cost of Two Hundred and Fifty thousand Ghana cedis (GHS250,000).

In attendance at the ceremony, held on the 9th of March 2023 at the Bongase Primary School were chiefs, elders and religious leaders as well as Directors and staff of BPA. Also in attendance were the DCE of the Banda District, Hon. Emmanuel Akoneh; a representative of the District Education Directorate, Madam Alimaru Amadu; the Headmaster, Mr. Prince Nkrumah; teachers and students of Bongase Primary School.

In his remarks, the CEO, Hon. Samuel Kofi Ahiave Dzamesi highlighted how keen the Authority is, through its Corporate Social Responsibility, in improving the lives of the people in the area and within the district especially in education. He commended the DCE for his relentless effort in ensuring the progress of these communities.



He assured all gathered of the continuous support of the Authority, especially in the education of the people whilst encouraging the students to concentrate on their studies. He also stressed the importance of proper maintenance of the property by the school to ensure its longevity. At the end of the ceremony, the CEO, Hon. Dzamesi handed over the keys to the DCE who in turn handed them over to the Representative of the District Directorate of Education and finally to the Head Teacher, Mr. Nkrumah.





BUI POWER AUTHORITY COMMISSIONS AND HANDS OVER NURSES' QUARTERS

Hon. Samuel Kofi Ahiave Dzamesi on Thursday, 9th March 2023 commissioned and handed over a nurses' residential quarters as part of the Authority's Corporate Social Responsibility on health, during his working visit the Bui Generating Station.

The quarters' was built to alleviate the struggles that health workers face when posted to the Bui CHPS Compound built by the Authority.

Attending the ceremony, the Chief of Bui, Nana Kwadwo Wuo II thanked the Authority for its contribution to the total development of the area and the district at large.

He was particularly happy that the long-time headache of finding accommodation for health workers posted to his community, has been made less severe by the Authority. He acknowledged the impact the staff quarters for the nurses will have on their overall service delivery. The quarters will

also stop the sudden migration of nurses posted to the community as accommodation was their biggest challenge.

In his remarks, the CEO, Hon. Samuel Kofi Ahiave Dzamesi was happy to inform the gathering, of the Authorities commitment to its responsibility to the well-being of the community and help will always be considered when and if possible.



Hon. Samuel Kofi Ahiave Dzamesi also spoke about the collaboration between the Authority, the Sunyani University and Berlin University for training and exchange programs for Engineering Students.



The programs, estimated at a cost of one million euros (€1,000,000) according to the CEO will go a long way to train more engineers who can be absorbed into the Authority. He further added that, he has so much confidence in Ghanaians to man and even build more of such dams which is the aim of the collaboration. The CEO, in conclusion, strongly stressed to the community, the need for a culture of maintenance and the need to keep the facility in good condition, the lack of which he stated, will only curtail any assistance being provided.

CEO ENGAGES INTERNAL STAKEHOLDERS

The CEO, Hon. Samuel Kofi Dzamesi in line with his 2023 objectives, plans and activities held a series of engagements, over a two-week period with Departments within the Authority. The aim of this exercise is to intensify and build a better sense of commitment, trust and loyalty. These sessions were also held to aid the fostering of a motivated and engaged workforce.

Touching on the financial standing of the Authority, the CEO explained that the state of the economy has adversely affected the organisation and cited as an example, ECG's inability to pay BPA for the value of power purchased over the years, although BPA generated the most power last year, ever since its' inception.

Employees were also briefed about ongoing and upcoming projects. The office block, 96-aprtment accommodation block, solar expansion (floating and land), and the sugarcane Farm amongst others were some of the projects highlighted.



On the conditions of service of staff, the CEO acknowledged that, as expected, all staff are interested in their progression, in relation to promotions, training and remuneration, thus, he assured all, of the Authority's commitment in ensuring that the betterment of staff is high on the organisations priority list.



The CEO stressed on the need for a high standard of work ethics as this is the only way that we will be able to live up to our mantra of being the Renewable Energy Leaders. Hon. Samuel Kofi Dzamesi, addressed various issues raised by members of staff and admonished all to work with a sense of purpose and to cultivate a culture of information sharing.



Staff were applauded for their continued hard work which saw the Authority win many awards in 2022 including the much-coveted CEO of the Year (Power) at the Ghana Energy Awards. He also charged Directors and Unit Heads to hold similar sessions frequently to keep their staff abreast with happenings within the Authority.



COMMUNITY RELATIONS UNIT RENEWS ITS DE-MASSAGING CHARGE

The Community Relations Unit, through its Welfare Improvement mandate, deems it fit to promote practices that will safeguard the future of the communities within the BGS enclave. In this regard, the Unit facilitated a sensitization workshop program for chiefs, queens and opinion leaders within the enclave to promote the de-massaging of the heads of new born babies.

As part of its CSR efforts, the Authority partnered with Dr. Yael, a renowned child scientist, to organise a 3-day workshop, from 9th – 13th March 2023, for 30 participants. Attendants were made up of chiefs, elders, assemblymen and traditional birth attendants from the Banda and Bole Traditional Areas as well as some from the Bono and Savannah Regions. The sessions were held as part of what is Dr. Yael's second visit to the community. She is fulfilling a promise made on her first visit in 2022, to continually arrange such workshops which are of immense benefit to the community.

Using practical methods and tools, Dr. Yael managed to practically educate her audience on the dangers that come with the practice and charged them to spread the de-massage message in their communities.

The session afforded the participants the opportunity to dip thermometers in hot water to ascertain what the safest temperature of water is for a baby's head. She also advised on the dangers of using ointments such as ROBB with the intention of closing up the soft spots of the heads of babies.

CEO'S COURTESY CALL ON NORWEGIAN AMBASSADOR

At a working lunch on Tuesday, 14th February 2023, the CEO together with the Director, Renewable and the Manager, Corporate Affairs met with the Norwegian Ambassador and the Counsellor from the Royal Norwegian Embassy to discuss a potential partnership between BPA and Norway to scale up and support our renewable energy efforts.

The Ambassador, Ingrid Mollestad in welcoming the BPA Team to her Residence, expressed her delight in engaging Ghana's Renewable Energy Leaders with the aim of finding ways to assist Ghana to meet its target of adding 10% Renewable Energy to the country's Energy mix by 2030.

Norway boasts of an abundance of hydropower and has fostered energy-intensive industries and electric heating, therefore any opportunity to partner BPA in achieving its clean energy goals is very welcome.

The CEO, Hon Samuel Kofi Dzamesi was optimistic that with the steady development of Solar and other renewable energy projects by BPA, Ghana was sure to meet the 10% target of increasing the penetration of renewable energy in Ghana's energy mix.



Presenting on BPA's renewable Energy portfolio, the Director, Renewable Wisdom Togobo, spoke extensively about BPA's expanded mandate under the Bui Power Authority (Amendment) Act, 2020), Act 1046. He highlighted the ongoing solar energy projects being undertaken by BPA and emphasized the need to develop additional hydropower plants to hybridize the intermittent solar generation from solar.



He also outlined the effort of BPA to undertake feasibility studies on potential hydro sites on the Western rivers and appealed for the support of Norway for the development of the potential sites located on the Pra, Ankobra and Tano rivers.



Inquiring about BPA's renewable energy portfolio, Robert Hovde, Counsellor, was hopeful that BPA could benefit greatly from Norway's extensive experience in hydropower development and the development of e-vehicles. The counsellor also informed the CEO that a delegation of companies in the RE sector is expected to visit Ghana in the coming months from Norway, he invited BPA to play a lead role during the visit of the investment Team.

Opportunities for funding will also be available from the Norwegian Investment Fund for Developing countries to support renewable energy development.

BPA SUPPORTS ENSKINMENT OF YAGBONWURA-ELECT

As part of its Corporate Social Responsibilities, BPA makes it a point to support and safeguard the tenets of the indigenous Ghanaian culture to the best of its abilities. In line with this, on 21st March 2023, Dir. Estates Mr. Maxwell Wumbilla Salifu led a delegation of BPA staff from the Community Relations Unit to attend the enskinment of the Yagbonwura of the Gonja Kingdom, Tuluwewura Amonbafé Aborenyí I at Damango, on behalf of the CEO Hon. Samuel Kofi Dzamesi, after an invitation was extended from the kingdom to the Authority.

The Gonja Kingdom has long since held very cordial relations with the Authority, primarily because of its proximity to the BGS and this occasion was yet another display of the harmony that exists between the two parties.

The MOU stipulates that between 2022 and 2023, the Authority will organise scouting matches for the communities around the BGS in order to select, with assistance from the academy head, ex-Black Stars player, John Paintsil, five players from the entrants to be given professional training at the academy for 12 months; with the hope that they make it further into local or international leagues.

During a brief ceremony to handover the players officially to the John Paintsil Academy, the Chief Executive Officer of Bui Power Authority, Hon. Samuel Kofi Dzamesi, urged the players to be disciplined and aspire to become future football stars of Ghana. Mr. Paintsil, Director of the John Paintsil Football Academy, thanked the CEO, as well as the Authority and pledged that the academy will do everything in its power to better the players. He stated that he was very optimistic about the future of the players due to the qualities shown and that they had enough potential to compete in any international league.

The players took turns individually to thank the CEO and staff of BPA for the opportunity and gave the assurance of hard work to ensure that the trust put in them is not fruitless.

BPA SIGNS FIRE PROTECTION AGREEMENT

The Chief Executive Officer of Bui Power Authority (BPA), Hon. Samuel Kofi Dzamesi led a team from BPA to the Ministry of Interior to sign a Fire Protection Service Agreement between Bui Power Authority and the Ministry of Interior on behalf of the Ghana National Fire Service (GNFS) at the Ministry of Interior, Accra on April 13, 2023.

The Fire Protection Service Agreement is for the establishment of a Fire Station at the Bui Generating Station as part of measures to protect lives and properties within the Bui enclave.

After signing the agreement, the Minister for Interior, Hon. Ambrose P. Dery, commended the CEO of BPA, Hon. Samuel Kofi Dzamesi for his foresight and proactiveness in ensuring that a Fire Station is established at the Bui Generating Station to safeguard lives and the investments such as the Bui Hydro-electric Plant, Solar PV Systems, Estates, etc.



The Minister for Interior, whilst assuring BPA of the Ministry's support, tasked the Chief Fire Officer, Julius Kuunuor to ensure his personnel deployed to the Bui Fire Service exhibit high professional standards in the discharge of their duties.



The CEO of BPA, Hon. Samuel Kofi Dzamesi, in his remarks, expressed his gratitude to the Minister for Interior and Chief Fire Officer, CFO Julius Kuunuor for the deployment of a dual-purpose Fire Tender (FS 753) and sixteen (16) personnel which comprised two (2) Officers with fourteen (14) other Ranks deployed at the Bui Fire Station. Additionally, he indicated that the deployment of the Fire Tender and sixteen (16) personnel have undoubtedly enhanced the Fire Emergency Preparedness and Response at the BGS.



He further stated that two (2) new heavy-duty multipurpose tenders have been procured and arrangements are being made to conduct a Factory Acceptance Test on them by a Team from BPA and the GNFS before they are delivered in July this year.

Also present at the signing of the agreement were, the Technical Advisor to the Minister for Interior, Mr. Baba Bawumia, the Director of Legal GNFS, DCFO Kwasi Baffour Awuah, and from

BPA, the Deputy Director for Occupational Health and Safety, Mr. Chrisentus B. Kuunifaa, Snr Manager Legal & Board Secretary, Mr. Franklin Nana Addai, Senior Corporate Affairs Officer, Mr. Mawuli Fui Kwadzovia, and Corporate Affairs Officer, Ms. Adriana Appiah-Nkansah.



BONO REGIONAL MINISTER TOURS THE BGS

On March 30, 2023, the Bono Regional Minister, Hon. Justina Owusu-Banahene, and her entourage of nine (9) Municipal and District Chief Executives from the Bono region and members of the Bono Regional Security Council were taken on a tour of the 404MW Bui Generating Station (BGS).

The entourage was received in Bui by the Chief Executive Officer of Bui Power Authority (BPA), Hon. Samuel Kofi Dzamesi. On arrival the Minister's entourage interacted with the staff of BPA and proceeded to visit the site of the staff accommodation project, where the Authority is adding up to the existing living institutional accommodation. The minister also visited the BGS Powerhouse Control Room, Switchyards and the Dam Crest (the top of the dam where you can view the reservoir in its entirety).



The entourage also visited the ongoing installation of the 4MWp Floating Solar Plant on the Bui Reservoir as well as the land-based Solar PV farm where the Authority is operating an existing 50MWp Solar Plant and developing an additional 100MWp with an initial 10MWh battery energy storage system to allow the Solar PV to hybridize with the Hydro Plant.

Hon. Justina Owusu-Banahene praised the BPA CEO and staff of the Authority for their impressive efforts, in recognizing that the energy generated at the power plant was clean and environmentally friendly.
